

Memorandum of Association
For a Non-Profit Society

The name of the Society is LUNENBURG ROD AND GUN CLUB
(society name)

On a volunteer and non-profit basis the objectives of the Society are:

To provide a self-sustaining and fun club environment, with activities centered on various shooting disciplines (rifle, handgun and shotgun) and archery. The club is committed to safe and proper firearm handling at all times and caters for all members from beginners to the seasoned veteran. In addition, the club actively supports its members in the recreational pursuits of angling and hunting;

To improve, enlarge, repair, build, erect and maintain any building or facility suitable for the purposes of the club;

To raise funds for the purposes of the club by the holding of events, exhibitions or competitions;

To acquire by way of grant, gift, purchase, bequest, devise or otherwise, real and personal property and to use and apply such property to the realization of the objects of the club;

To buy, own, hold, lease, mortgage, sell and convey such real and personal property as may be necessary or desirable in the carrying out of the objects of the club.

Provided that:

- The club shall not carry on any trade, industry, or business;
- All funds shall be used solely for the purposes of the Society and the promotion of its objects;

Upon dissolution of the club and after payment of all debts and liabilities, its remaining property shall be distributed or disposed of to: *(choose one of the following)*

- qualified donees described in subsection 149.1(1) of the Income Tax Act ("charitable purposes").
- non-profit organization in Canada having objects similar to those of the society.

The activities of the Society are to be carried on in Lunenburg County, Nova Scotia
